

**OFFICIAL RULES FOR CENTERPOINT ENERGY RESOURCES CORP.'S  
NATURAL GAS GENERATOR PROGRAM POWER YOUR FALL FUN  
SWEEPSTAKES**

**1. Description of Promotions:** The Promotions are comprised of the CenterPoint Energy Natural Gas Generator Program Power Your Fall Fun (hereafter "Power Your Fall Fun") Sweepstakes consisting of the following prize levels:

**2. Eligibility:** The Power Your Fall Fun Sweepstakes is open to CenterPoint Energy natural gas customers in the Greater Houston area who are legal residents of the United States or the District of Columbia, and who are 18 years of age or older.

Employees, contractors, directors, or officers of any CenterPoint Energy company, any participating retail outlets, or any of their respective affiliates, radio sponsors, or advertising agencies, and members of their immediate families (spouse, grandparents, parents, siblings, children, and grandchildren) or persons residing in the same household of such employee are not eligible to participate. The Promotion is void where prohibited or restricted by law and are subject to all federal, state and local laws and regulations. ### **5. How to Enter the Promotion**

**How to Enter:** To enter the Power Your Fall Fun Sweepstakes, visit the CenterPoint Energy Natural Gas Generator Program sweepstakes promotional landing page and follow the instructions to complete the online entry form. **To enter the Power Your Fall Fun Sweepstakes without enrolling online**, hand-print your name, mailing address, telephone number (including area code), and email address on a 3” x 5” card and mail it in an envelope with proper postage affixed to CenterPoint Energy Power Your Fall Fun Sweepstakes; Natural Gas Generator Program ; P.O. Box 2628; Houston, TX 77252. Valid entries must contain all information requested. All entries become the property of Sponsor and will not be acknowledged or returned. Any other form of entry is void. No mechanical reproductions will be accepted. Sponsor is not responsible for lost, late, illegible, misdirected, mutilated, incomplete, or postage-due or incomplete mail/entries.

**Limit: one (1) entry in the Power Your Fall Fun Sweepstakes per household, regardless of the method of entry.**

Should multiple users of the same email account enter the Power Your Fall Fun Sweepstakes and a dispute thereafter arises regarding the identity of the entrant, the authorized account holder of said email account at the time of entry will be considered the entrant. “Authorized account holder” is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization which is responsible for assigning email addresses or the domain associated with the submitted email address. Sponsor reserves the right, at its sole discretion, to disqualify any individual (and all of his or her entries) who tampers with the entry process.
