- Trade ally incentives will be issued quarterly.

Trade ally ID number

CenterPoint assigns a six-digit trade ally ID for your incentives, which is also used to expedite rebate processing. In order to assign your company ID, CenterPoint requires a current W-9 to be on file, which we update every two years in tax compliance.
