Install free natural gas saving products and/or get rebates for larger, high-efficiency natural gas equipment and other energy-saving projects.

Steps to participate:

1. Contact CenterPoint Energy's contractor and program administrator, CLEAResult, to learn how the CenterPoint Energy Commercial & Industrial Solutions Program can benefit your facility.
2. Sign and submit the Participation Agreement (see back).
3. Work with the program administrator to formally identify energy efficiency project opportunities, quantify prospective energy savings and reserve CenterPoint Energy rebates.
4. Schedule your assessment, implementation and post-project completion inspection(s).

6. Receive cash rebates from CenterPoint Energy.

FREE low-flow spray valves and faucet aerators

The Commercial & Industrial Solutions Program technicians will install – at no-cost to you – natural gas and water-saving products, as is appropriate for your operation. Items commonly include high-efficiency spray valves and faucet aerators. Together, these measures can save you hundreds of dollars per year in natural gas and water costs. Best of all, they're available at no cost to you, and installation is free, too! See the chart below for natural gas and dollar savings.

Utility savings achieved with low-flow pre-rinse spray valves

Daily hours of use	Daily water savings (gallons)	Daily sewer savings (gallons)	Daily gas savings (therms)	Annual dollar savings
1	60	60	0.5	\$250
2	120	120	1	\$500
3	180	180	1.5	\$750

Rebates for customized energy solutions

The Commercial & Industrial Solutions Program offers rebates toward other high-efficiency equipment and energy-saving processes. Depending on the facility type and operating characteristics, eligible measures may include:

- Boiler retrofits and improvements
- Controls
- Process efficiency improvements
- Other natural gas-related equipment and processes
- HVAC systems
- Building thermal improvements
- Water heating improvements

No-cost facility audit

Many industrial operations use large amounts of natural gas for process heating and steam production. Program representatives will perform a valuable no-cost facility audit, to determine if any natural gas is being used inefficiently and help identify cost-effective solutions to reduce energy waste and save money.

Program deadlines

The CenterPoint Energy Commercial and Industrial Solutions Program will offer rebates for eligible natural gas efficiency savings achieved by projects completed no later than December 1 of the current program year. Alternate deadlines up to December 31, 2013 may be considered on a case-by-case basis.

- Participant will complete and submit required paperwork, including supporting documentation, in a timely manner, according to Program Rules.
- Participant will consider adoption of cost effective energy efficient technologies and practices that, without the existence of the Program, would have been cost prohibitive.
- Participant agrees that participation in this Program shall impose no liability on CenterPoint Energy and that, in particular, CenterPoint Energy shall not be liable to Participant or any third party for any direct, indirect, punitive, special, incidental or consequential damages, including, without limitation, lost revenues or lost profits, arising out of or in any way connected with Participants' participation in the Program.
- Participant may be eligible to receive direct installation of specific energy saving devices which are provided at no cost to the Participant. If electing to receive direct installation of energy saving equipment, the Participant agrees to maintain the equipment for a minimum of one (1) year and has 30 days to request the replaced equipment. In the event that any of the energy saving devices are removed prior to the one year minimum term, the Participant agrees to notify CLEAResult.
