HEATING SYSTEM REBATE

REBATE GUIDELINES

The qualifying equipment must be installed in a home or business with natural gas service from CenterPoint Energy in Arkansas or the Texas communities of Texarkana, Nash, Redwater or Wake Village between January 1 and December 31, 2014.

Dealers/Installers are not eligible to receive their customer's rebate.

Building contractors should negotiate with homeowners to determine who receives the rebate.

Equipment installed under warranty replacement does not qualify for the rebate.

CenterPoint Energy reserves the right to inspect the installed equipment.

Rebate applies to new natural gas equipment listed and AFUE verified in the Air Conditioning, Heating and Refrigeration Institute (AHRI) directory. See: www.ahridirectory.org

^{*}Back-up heating system rebates apply only to new natural gas furnaces used as back-up systems to heat pumps for new construction or natural gas retrofits, not for electric heating retrofits to natural gas.

Please note: Replacing an electric resistance furnace for a natural gas system is not eligible for a rebate.

REBATE APPLICATION

Work with your heating dealer to complete the entire rebate application and obtain a dated sales invoice showing the detail of what was purchased and installed.

DATED SALES INVOICE

- Must be included with the completed application.
- Must include the brand, complete model number and serial number.
- Must include the purchaser's name and installation address.

We are unable to accept applications that do not include all of the requested information.

REBATE PROCESSING

Rebate will be issued for equipment installed between Jan. 1, and Dec. 31, 2014.

In order to secure your rebate, please send in your rebate application within 90 days of installation or by year end (Dec. 31), whichever comes first.

Account number must be activated for installation address in order for rebate to be processed.

Completed rebate forms are awarded in the order received until program funds are depleted. Rebate qualifications and amounts are subject to change. Rebate funds are limited. Program funds are anticipated to be available annually and are subject to approval from the Arkansas Public Service Commission. CenterPoint Energy Conservation Improvement Program (CIP) rebate programs may be cancelled or changed at any time. CenterPoint Energy is not responsible if the dealer/installer does not provide accurate information about the amount of a rebate or equipment eligibility.

CenterPoint Energy issues a cash rebate, not utility bill credits. Please allow 8 weeks to receive payment in the mail from the time that CenterPoint Energy receives your completed paperwork.
