IMPORTANT REQUIREMENTS

1. Steam Trap rebate amount.

Equipment	Efficiency Requirement	Rebate Amount
Commercial heating steam trap repair/replacement	Failed open or leaking Float & Thermostatic (F&T), Bucket, & Thermostatic style	35% of repair/replacement steam trap equipment cost. \$10,000 building cap.

2. Steam trap pass/fail information required to identify condition of steam traps.
3. Rebates are paid on space heating steam traps only (not process steam traps).
4. If you are a trade ally, your six digit ID number is required to participate in the Trade Ally Incentive Program. If you do not know your ID#, please contact CenterPoint Energy at 612-321-4330.
5. All qualifying equipment must be fully installed and operational.
6. Enclose invoice showing separate figures for equipment, labor, and taxes.
7. All required information must be submitted before rebate can be paid.
8. To qualify for a rebate, the steam trap replacement or repairs must be made on equipment that is the facility's primary source of heat and served by natural gas from CenterPoint Energy in Minnesota for a commercial or industrial account.
9. Applications must be received by December 31 of the calendar year in which the equipment is installed. To avoid delays in rebate processing, please submit your paperwork as soon as equipment installation is complete.
10. Please allow six to eight weeks for rebate processing. Rebate checks will be issued to the name listed on the CenterPoint Energy account.

Multi-Family Affordable Housing Program: Qualifying properties are eligible for a bonus rebate of 25%.

- Program Eligibility: The building must be customer of CenterPoint Energy in Minnesota with a commercial natural gas account and have a minimum of five housing units. A minimum of 66% of the units occupied by income eligible households.
- Eligibility can be demonstrated by submitting supporting documentation to your CenterPoint Energy account manager through the following manners:
 - Buildings certified for the Department of Energy Weatherization Assistance Program (WAP) are automatically eligible.
 - Buildings certified for the Minnesota Low Income Rental Classification (LIRC) are automatically eligible.
 - Use Restrictions or Mortgage Covenants which restrict minimum of 66% of housing units to income eligible households can be used to demonstrate eligibility.
 - Other means of demonstrating eligibility, including (but not limited to) participation in the project-based Section 8 voucher program or other county or state funded program may be acceptable.
