IMPORTANT REQUIREMENTS

1. Boiler tune-up rebate amounts.

Equipment	Rebate Amount
Boiler tune-up	25% of tune-up costs; cap of \$300 per boiler

2. If you are a trade ally, your six digit ID number is required to participate in the Trade Ally Incentive Program. If you do not know your ID#, contact CenterPoint Energy at 612-321-4330.

3. All tune-up work must be completed as described to qualify for the rebate.

4. Technician must complete the following for each boiler that qualifies for a Boiler Tune-Up Rebate

- Measure combustion efficiency using an electronic flue gas analyzer.
- Adjust air flow and reduce excessive stack temperatures.
- Adjust draft control.
- Check adequacy of combustion air intake.
- Clean fire side of heat exchanger.

5. Individual boilers are eligible for tune-up rebates only once every other year.

6. All required information must be submitted before rebate can be paid, including contractor invoice itemizing tune-up costs in the following categories:

- Labor*
- Analyzer charges*
- Supplies (cleaning and CO2)*
- Truck charges*

**Rebate paid on labor, analyzer, supplies required to perform tune-up and truck charges only.*

Post-combustion efficiency readings must also be submitted to CenterPoint Energy.

7. Boiler Tune-up must be performed on equipment served with natural gas from CenterPoint Energy in Minnesota for a commercial or industrial account.

8. All applications must be received by December 31 of the calendar year in which the tune-ups take place. To avoid delays in rebate processing, please submit your paperwork as soon as the tune-up is complete.

9. Please allow six to eight weeks for rebate processing. Rebate checks will be issued to the name listed on the CenterPoint Energy account.
