## TERMS & CONDITIONS

The qualifying equipment must be installed in a home or business with natural gas service from CenterPoint Energy in Oklahoma between January 1 and December 31, 2019. All completed applications must be post marked by December 31, 2019 to be considered for a rebate.

### CenterPoint Energy reserves the right to inspect the installed equipment.

#### Note:

- Only new equipment is eligible for rebate (no refurbished equipment); must be installed and fully operational at time of submitting rebate application.
- Rebates are calculated on equipment cost only; not on taxes, labor, unattached materials, piping or controls.
- Equipment must meet the efficiency standards outlined in the following table:

EQUIPMENT	REBATE AMOUNT
Fully modulating or 6 step modulation boiler burner	\$1,000/MMBTUH input; Not to exceed 25% of equipment cost

## APPLICATION

- Complete entire rebate application and obtain a dated sales invoice showing the detail of what was purchased and installed.
- In order to secure your rebate, submit your rebate application by year end (Dec 31) of year equipment is installed and operational.
- Must enclose boiler efficiency documentation for all equipment.
- It is the responsibility of the customer to ensure that the installed equipment qualifies for the rebate. If it does not qualify, the rebate will not be paid.

## DATED SALES INVOICE OR SALES RECEIPT REQUIREMENTS

- Must be included with the completed application
- Must include the customer's name and installation address
- Must include the equipment manufacturer, complete model number, & serial number
- Must include pricing information with separate figures for equipment, labor and taxes

**CenterPoint Energy is unable to accept applications that do not include all of the requested information. Application will be returned if information is missing.**

## PROCESSING

Completed rebate forms will be processed in the order in which they are received and are paid on a first-come, first served basis. Account number must be activated for installation address in order for rebate to be processed. CenterPoint Energy is not responsible if the dealer does not provide accurate information about the amount of a rebate or equipment eligibility. Rebate qualifications and amounts are subject to change. CenterPoint Energy Conservation Improvement Program (CIP) rebate programs may be cancelled or changed at any time.
