PROGRAM DETAILS

A Recommissioning Study helps CenterPoint Energy customers identify low-cost and no-cost energy-saving measures that, when implemented, will reduce operating costs and improve the efficiency of the existing mechanical systems in their commercial buildings. CenterPoint Energy will provide funding to our customers to offset a portion of the study costs for a third-party study provider to identify the energy savings measures. Funding levels are dependent upon projected gas savings potential at the facility. Funding provided by the customer's electric utility does not disqualify the customer from applying for additional gas-related funding through CenterPoint Energy. CenterPoint Energy will also rebate qualifying implemented gas-savings measures.

Application Instructions

Application must be completed and submitted along with the study proposal (see "Required Proposal Content").

Application Qualifications

Customer must get study funding pre-approval from CenterPoint Energy prior to initiation of the study.

Applications for projects already initiated will not be accepted.

Required Proposal Content

The study provider's proposal must include the following details:

- Description of facility
- Description of existing HVAC system/gas-related systems and components
- Clearly stated purpose for the need of the evaluation
- Preliminary recommendations
- Specific objectives set by the customer

Required Study Content

The evaluation report must include the following details:

- A detailed description of the facility, including the gas-related systems and components.
- A description of the energy conservation measures, including the gas-related aspects of these measures.
- A detailed description of the existing equipment, location, capacity, and operational characteristics including type of controls and history of energy usage.
- A description of the proposed changes and the effect on annual usage including control changes.
- If necessary, any drawings, sketches, calculations, field measurements, or additional information to assist justification of the recommended changes.
- An annual energy estimate of the planned savings, including all detailed supporting calculations.
- Submit a draft study to CenterPoint Energy.

Project Funding

- The project will provide funding for recommissioning studies up to 75% of the study cost, not to exceed \$10,000 per study.
- Rebates will also be provided to participants who implement all or some of the recommendations included in the study.
- Qualifying measures must have a payback of between one year and 15 years.
- Implementation rebates will be \$5 per Dth of energy savings.

- CenterPoint Energy reserves the right to make the final decision on the total amount of the study funding.
- Customer's facility must be served by CenterPoint Energy with natural gas as the primary source of energy to the process being studied, and the customer's accounts must be in good standing.
