## IMPORTANT REQUIREMENTS

1. Condensing condo packs, condensing unit heaters and infrared heater rebate amounts.

Equipment	Efficiency Requirements	Rebate Amount
Condensing condo packs	≥ 90% Thermal efficiency	\$150/unit
Condensing unit heater	≥ 88% Thermal efficiency	\$300/Condensing unit heater; Not to exceed 25% of equipment cost
Infrared heater	Low intensity tube type	\$250/Infrared Heater

2. If you are a trade ally, your six digit ID number is required to participate in the Trade Ally Incentive Program. If you do not know your ID#, contact CenterPoint Energy at 612-321-4330.

3. All qualifying equipment must be fully installed and operational.

4. Enclose invoice showing separate figures for equipment, labor, and taxes.

5. All required information must be submitted before rebate can be paid.

6. Qualifying equipment must use natural gas provided by CenterPoint Energy in Minnesota for a commercial or industrial account.

7. Applications must be received by December 31 of the calendar year in which the equipment is installed. To avoid delays in rebate processing, please submit your completed paperwork as soon as equipment installation is complete.

8. Please allow six to eight weeks for rebate processing. Rebate checks will be issued to the name listed on the CenterPoint Energy account.

**Multi-Family Affordable Housing Program:** Qualifying properties are eligible for a bonus rebate of 25%.

- Program Eligibility: The building must be customer of CenterPoint Energy in Minnesota with a commercial natural gas account and have a minimum of five housing units. A minimum of 66% of the units occupied by income eligible households.
- Eligibility can be demonstrated by submitting supporting documentation to your CenterPoint Energy account manager through the following manners:
  - Buildings certified for the Department of Energy Weatherization Assistance Program (WAP) are automatically eligible.
  - Buildings certified for the Minnesota Low Income Rental Classification (LIRC) are automatically eligible.
  - Use Restrictions or Mortgage Covenants which restrict minimum of 66% of housing units to income eligible households can be used to demonstrate eligibility.
  - Other means of demonstrating eligibility, including (but not limited to) participation in the project-based Section 8 voucher program or other county or state funded program may be acceptable.
