How to apply for rebates

Program dates: Jan. 1 – Dec. 31

Three simple steps to receive a rebate:

2. **Mail or email the completed paperwork so it is received by Dec. 31.**

Allow six to eight weeks for rebate processing.

3. **Rebate applications must include a dated copy of the paid, itemized invoice(s).** Invoice(s) must include brand, complete model number, purchaser's name, and installation address.

Start earning trade ally/dealer incentives today!

Three simple steps to incentives:

1. Submit a W-9

For tax purposes, and to pay your incentives, we need a copy of your W-9 on file every two years. To get payments faster, fill out an EFT form and incentives will be deposited directly into your bank account.

2. Receive a trade ally/dealer ID

Once we have your W-9, we'll assign a six-digit dealer ID to track and pay your incentives. Remember to include it whenever you submit a rebate application

3. Send completed application


Submit rebate forms as you complete installations. We will mail your customer's rebate upon processing and send your incentive checks after the end of each quarter.

Terms and conditions apply. See detailed qualifications, rules, and requirements on the rebate application.

Program dates. Rebates are for qualifying equipment installed Jan. 1–Dec. 31. Rebate applications must be received by Dec. 31 of the year equipment is installed.
