Homeowner and renter programs (one-to-four-unit properties)

Home Energy Squad

Our experts will lay out a personalized energy plan for your home and install energy-saving items to qualifying households free of charge that may include programmable thermostats, low-flow showerheads and kitchen and bathroom aerators to designed to reduce your home's energy usage.

Weatherization

Income-qualified homeowners and renters can receive an energy assessment at no cost. This assessment finds measures to improve a home's energy efficiency, and after approved, they are installed at no cost to the customer. They can include but are not limited to attic and wall insulation, sealing of air leaks, plus repair or replacement of natural gas furnace (or boiler) and water heater.

To qualify customers must participate in the Minnesota Department of Commerce Energy Assistance program.

Heating system tune-up

Income-qualified customers are eligible to receive a free heating system tune-up and safety check every two years. The service is offered in partnership with local Community Action Partnership (CAP) Agencies and are performed by an authorized CenterPoint Energy Home Service Plus technician. Qualified customers are randomly selected based on eligibility. Appointments are limited.

Eligible customers will be contacted by CenterPoint Energy to schedule an appointment typically between February and April each year.

Affordable housing organization programs

Non-profit affordable housing for one-to-four-unit new construction and retrofit properties

Program offers substantial incentives for energy efficiency measures installed by partnering with affordable housing organizations in their one-to-four-unit new construction and retrofit income-qualified housing. Rebates cover the approximate incremental cost for upgraded insulation and air sealing, plus higher-efficiency natural gas heating, water heating and other equipment in projects sold to income-qualified homebuyers or operated by the organization as rental units.

Building owner programs

Rental efficiency for one-to-four-unit properties

Offers incentives for energy-saving improvements made by owners of one-to-four-unit dwellings that house income-eligible renters. This shared-cost model provides a free energy audit and pays 50 percent of the cost for qualifying installed weatherization upgrades and high-efficiency equipment replacements. Rental properties with 50 percent or more of units occupied by income-qualified tenants are eligible to participate.

Services are provided through our program partner, Energy Cents Coalition.

Multi-Family Building Efficiency for five plus unit properties

Offered in partnership with Xcel Energy, this program provides a "one-stop shop" to help owners of multi-family buildings accomplish whole-building natural gas and electric energy efficiency savings.

Program includes:

- A free on-site, no-cost energy efficiency audit with a thorough report of findings and recommendations on ways to improve your building's energy efficiency
- Free installation of energy-saving products, such as light-emitting diodes (LEDs) and showerheads, throughout common areas and resident units
- Up to 3X bonus incentive to rebates earned up to the cost of the equipment for eligible income-qualified properties
