



## Reduce energy use and operating costs with our 2025 Indiana Natural Gas Business Prescriptive Programs.



The Natural Gas Business Prescriptive Program provides rebates for common energy-efficient equipment installs and upgrades at your business facility.

### Eligibility

CenterPoint Energy Indiana commercial and industrial customers that receive natural gas service with rates 120, 125, 220 or 225 are eligible for rebates. **Terms and conditions apply.**

All installations must be new equipment, with the exception of steam trap repairs. **Applications for rebates in excess of \$20,000 per facility per year MUST be pre-approved by CenterPoint prior to purchasing or installing equipment.** See the Business Prescriptive Program application for more details.

### Examples of qualifying natural gas projects

Here are some examples of common energy-saving projects that may qualify for a Business Prescriptive Program rebate at smaller facilities, such as schools, offices, auditoriums, warehouses, retail locations and grocery stores.

- **Boilers:** Boilers, boiler reset controls and boiler tune-ups
- **Space heating:** Thermostats, furnaces, advanced rooftop controls and infrared heaters
- **Water heaters:** Storage and tankless units
- **Commercial kitchen:** Fryers, convection ovens and steam cookers
- **Steam traps:** Replacement or rebuilding of traps that are leaking steam

# How the program works

## Pre-installation

- Identify a possible energy-efficiency project at your facility.
- Visit **CenterPointEnergy.com/INBusinessRebates** to view a complete list of qualifying natural gas projects and the available rebates.

## Installation

- Download and complete a Business Prescriptive Program application.
- Download and complete the measure selection form(s) associated with the rebate(s) you are applying for.
- Purchase and install your energy-saving equipment.

## Post-installation

- Submit your completed application along with the measure selection form(s), technical data sheets and copies of all equipment and services invoices within 90 days of project completion.
- After a project review is complete and your rebate is approved, you will receive a rebate check in the mail.
