



The natural gas business Custom Program provides incentives to CenterPoint Energy's Indiana commercial and industrial customers (with service rates 120, 125, 220, or 225) for eligible natural gas projects that incorporate energy-efficient, cost-saving technologies. These incentives can help reduce the initial costs of implementing energy efficiency improvements.

## Eligibility

CenterPoint's Indiana commercial and industrial natural gas service customers with service rates 120, 125, 220 or 225 are eligible for Custom Program rebates. **Terms and conditions apply.**

## Examples of qualifying natural gas projects

Here are some examples of energy-saving projects that may qualify for a Business Custom Program incentive:

- Natural gas heating, ventilation and air conditioning (HVAC) projects
- Natural gas domestic water heating system control upgrades
- Outside air control projects
- Enhancements to air distribution, zoning and control of infrared heating systems
- Grain dryer upgrades
- Waste heat recovery projects

**Applications for custom rebates MUST be preapproved by CenterPoint prior to purchasing or installing equipment and cannot be initiated prior to this. Allow up to four weeks to receive the preapproval notice.**

## Current program incentive

The current rebate incentive is up to \$1.00 per therm saved on projects with a simple payback greater than one year. Project incentives are capped at 50% of project costs or \$100,000.

## How the program works

### Pre-installation

- Identify a possible energy-efficiency project at your facility.
- Download, complete and submit a Business Custom Program application prior to purchase or installation of equipment, along with a project summary, estimated cost and proposed energy savings. Your application and supporting documentation are reviewed to determine rebate eligibility.

**Do not purchase equipment prior to application approval.**

### Installation

- Once your application is reviewed and approved, you will receive a project pre-approval letter. You can now purchase equipment and begin work on your project.
- If your project will not be completed within the pre-approved timeframe, contact us with your new estimated completion date to request an extension.

### Post-installation

- When your project is finished, submit an itemized invoice, your project installation notice (PIN) and any final documentation. A program staff member may contact you to conduct a site visit to collect additional information, if need be.
- After the final review is complete, a rebate check will be mailed to you.

## Rebates for our electric business customers

CenterPoint Energy of Indiana business customers with electric service in Posey, Gibson, Vanderburgh, Warrick, Pike, Dubois and Spencer counties can qualify for rebates on energy-saving projects. The rebate incentive is \$0.14 per kilowatt-hour (kWh) saved with a simple payback greater than one year. Project incentives are capped at 50% of costs or \$300,000.

## Energy-saving project snapshots

### Trifecta Medical - HVAC project

- Measures implemented: Install energy rotation units for heating
- Total project cost: \$21,805
- Estimated annual energy savings: 6,956 therms
- Estimated annual cost savings: \$4,794
- Rebate: \$6,956
- Estimated payback period without rebate: 3.3 years
- Estimated payback period with rebate: 1.8 years
