2. COMMERCIAL FIRM SALES SERVICE (CS-1)

2.1. AVAILABILITY

2.1.1. This rate schedule is available at points of adequate capacity and suitable pressure on the Company's existing facilities. This rate schedule is available to any customer engaging in business, professional, institutional or other non-residential activity supplied at an individually metered point of delivery for all uses of gas. Natural gas supplied hereunder is for the individual use of the customer at the point of delivery and shall not be resold or shared with others. Standby service is not available under this rate schedule.

2.1.2. This rate schedule is available to irrigation customers using volume in excess of 5,000 Ccf up to 365,000 Ccf in any 12 consecutive month period.

2.1.3. Gas consumption under this rate schedule is limited to usage in excess of 5,000 Ccf but less than or equal to 365,000 Ccf in any 12 consecutive month period. If at any time, it is anticipated, based on Company's estimate, that the customer will consume in excess of 365,000 Ccf per year in the succeeding 12 consecutive month period, the customer shall become subject to the applicable large commercial firm service rate schedule.

2.2. TRANSPORTATION SERVICE OPTION

2.2.1. Any customer which has used or anticipates using at least an average of 10 Mcf per operating day during the preceding or succeeding twelve (12) months qualifies for the Transportation Supply Option (TSO) under Rate Schedule No. 3. Customers which elect the TSO shall be subject to all terms and conditions of service under Rate Schedule No. 3, relating to the

Delivered volumes will be adjusted by the appropriate thermal content factor, obtained from the nearest available chromatograph or sampling location (Ccf/10 X thermal content factor = MMBtu).

- (i) SSO – The Gas Supply Rate will be calculated and adjusted periodically as defined in the Company’s Gas Supply Rate Rider.
- (ii) TSO – TSO customers will be required to provide LUFG-in-Kind at the percentage specified in the Company’s Gas Supply Rate Rider. Customers electing the TSO R1 option shall pay the G-2 component.

For those customers purchasing from the Company a portion of their gas service requirements under this rate schedule and contracting for the delivery of the remainder of their gas service requirement pursuant to the applicable transportation rider, the first volumes through the meter for each billing period, up to the maximum allocation of sales demand made pursuant to the applicable transportation rider, shall be considered sales volumes for purposes of billing the Gas Supply Rate. The Distribution Rate shall apply to total volumes for the billing period, without regard to whether the volumes are sales volumes or transportation volumes. However, transportation volume billing shall begin, pursuant to the rates set forth in the applicable transportation rider, in the corresponding Distribution Rate billing block where sales volume billing concluded.

2.3.2 Monthly Contract Administration Fees applicable to customers under the TSO, described in Part 2.2. of this rate schedule, are \$450.00 per month.

2.4. MINIMUM CHARGE

The sum of (a) and, if applicable, (b):

- (a) Monthly Customer Charge – \$86.03
- (b) Contract Administration Fee - TSO – \$450.00 per month.

2.5. TELEMETERING

2.5.1. Telemetering is required under the TSO described in Part 2.2.1. of this rate schedule. If Company does not have telemetry at customer's point of delivery, upon execution of the Agreement, Company shall install telemetry equipment of standard make and manufacture to determine hourly and daily flow of gas at customer's point of delivery. Customer shall choose between analog telemetry and wireless telemetry, if suitable wireless service is available. Customer will pay Company for telemetry equipment under one of the following payment options as chosen by the customer:

- a. Customer will reimburse Company for the full, installed cost of such telemetry equipment.
- b. Customer will pay Company a monthly fee per meter for the entire period such meter(s) is(are) served under this or any other transportation rate schedule as follows:

Telemetry without pressure instrumentation	\$30 per meter
Telemetry with pressure instrumentation	\$120 per meter

2.5.2 If customer chooses analog telemetry, then customer shall be responsible for installing and maintaining telecommunications lines. Should customer fail to maintain or repair telecommunications lines required to communicate with telemetry equipment, Company shall have the right to bill customer all labor and expense required to manually read the meter, at whatever intervals the Company may deem necessary.

2.7.1. The Oklahoma Corporation Commission Rules and Regulations Prescribing Standards for Gas Service and the otherwise applicable provisions of the Company's tariffs as presently on file with the Oklahoma Corporation Commission, as the same may from time to time be changed in accordance with the law, shall be applicable to service under this rate schedule.
