CenterPoint Energy has begun a multi-year construction project to replace approximately 74 miles of large diameter steel natural gas transmission pipeline known as the Belt Line. Rehabilitation of the Belt Line is important to ensure the long-term reliability and continued safety of the pipeline infrastructure serving hundreds of thousands of customers in the metro area.

As a system upgrade project, Minnesota Limited, LLC., an authorized CenterPoint Energy contractor, will replace 450 feet of 24-inch diameter steel pipe along 24<sup>th</sup> Avenue N., between Washington Avenue N. and 2<sup>nd</sup> Street N (see map for detail). Construction is expected to begin the week of August 10, 2015 and will require approximately one month to complete the work. We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.
