

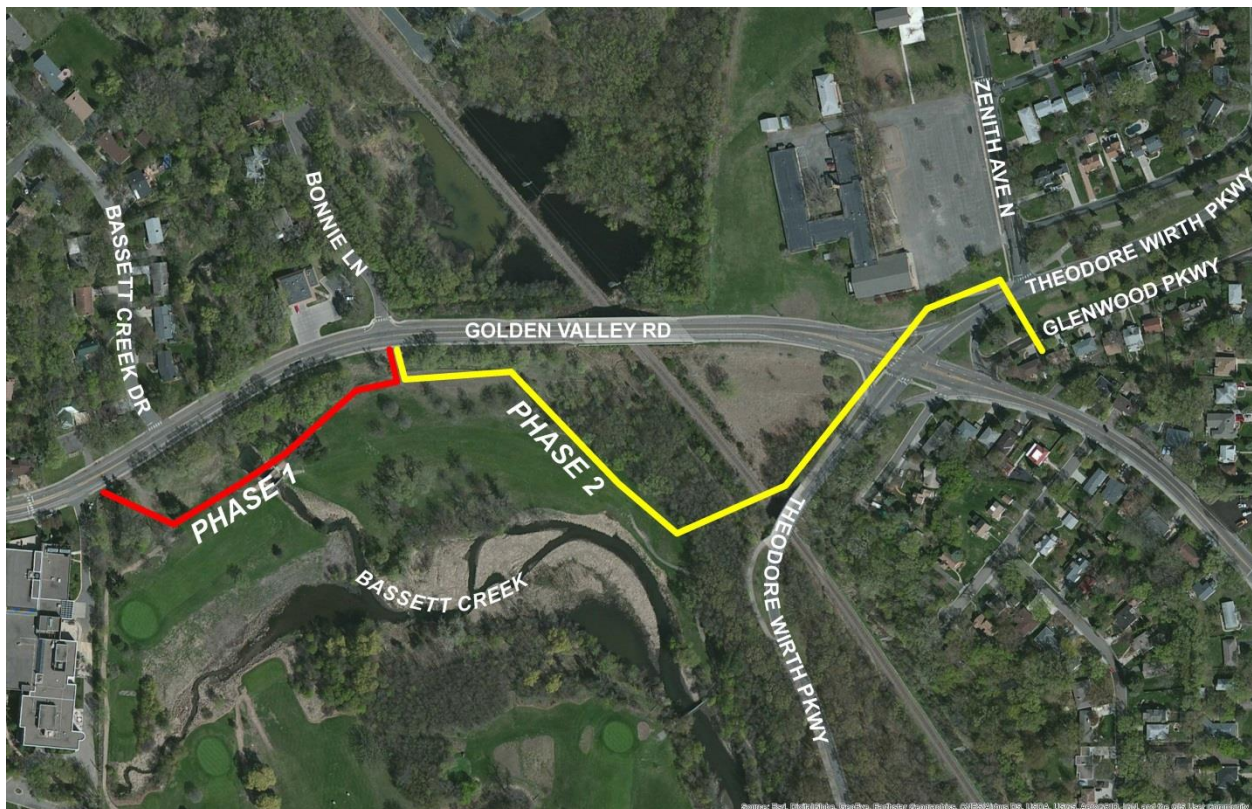

NOTICE: CenterPoint Energy to upgrade natural gas pipelines near your neighborhood April 3 – early May 2017

*Text-to-subscribe for updates regarding this construction project by sending **CNP GOLDENBASSETT to 468311***

- As a system upgrade project, CenterPoint Energy will be replacing natural gas transmission pipeline south of Golden Valley Road, across from Basset Creek Drive and Bonnie Lane. Work will occur primarily in the utility right of way located in Theodore Wirth Golf Course.
- The pipeline replacement project has two phases as highlighted in the map below. Only phase one will be constructed at this time.
- Minnesota Limited, CenterPoint Energy's authorized contractor, will begin work on Monday, April 3, and anticipates completing phase one by early May 2017.
- Lane restrictions are anticipated on Golden Valley Road where pipeline connections will be made as part of the project. Signage will alert drivers regarding the necessary lane restrictions designed to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy will begin replacing a natural gas distribution pipeline Monday, April 3. Work is anticipated to be complete by early May 2017, weather permitting. The project consists of two phases as highlighted on the attached map; only phase one will be constructed at this time. CenterPoint Energy's work is being completed prior to the start of a Hennepin County project involving Golden Valley Road in the area of Bassett Creek Drive and Bonnie Lane. Minnesota Limited, an authorized CenterPoint Energy contractor, is anticipated to begin the replacement of the existing natural gas transmission line associated with phase one, beginning on Golden Valley Road west of Bassett Creek Drive, and then progressing in the utility right of way located in Theodore Wirth Golf Course. Lane restrictions on Golden Valley Road are required when construction activity is occurring on the roadway and is necessary to keep both the public and construction personnel safe. Project updates will be available at CenterPoint Energy's website at CenterPointEnergy.com/Construction.

This construction will happen in two phases: Phase one will occur along Golden Valley Road from west of Bassett Creek Drive to Bonnie Lane, in the utility right of way located in Theodore Wirth Golf Course. Phase two, as highlighted on attached map, will occur in the utility right of way in Theodore Wirth Golf Course, between Bonnie Lane to Theodore Wirth Parkway and Glenwood Parkway, and along Theodore Wirth Parkway from the railroad to Zenith Avenue N. A separate notice will be sent out prior to phase two construction work, which may occur fall 2017. Both phases will consist of installing the natural gas transmission pipe and after each phase is done construction crews will restore disturbed roadways and soft surfaces (right of way).
