

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood June – August 2017

- As a system upgrade project, CenterPoint Energy will be replacing natural gas pipeline in the St. Louis Park neighborhood along W. 29th Street and Minnetonka Boulevard going westward from Vernon Avenue S. to Louisiana Avenue S. (See map below for details.)
- CenterPoint Energy's construction is expected to start in June 2017 and end in August 2017.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated
 in areas where active construction is occurring. The lane restrictions are necessary to keep
 both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

An open house is scheduled for May 2 from 5:30 p.m. to 7:00 p.m. at the St. Louis Park City Hall at 5005 Minnetonka Boulevard. The meeting will take place in the Council Chambers. Representatives from the City of St. Louis Park as well as CenterPoint Energy personnel will discuss details of the project and will invite questions or comments from the public.

Crews from CenterPoint Energy will begin replacing an existing natural gas pipeline in St. Louis Park in June 2017. Project construction is expected to last until August 2017. Michels Corporation, an authorized CenterPoint Energy contractor, will begin installing natural gas distribution mains along the curb side of westbound W. 29th Street and Minnetonka Boulevard going westward from Vernon Avenue S. to Louisiana Avenue S. (See map on opposite page.) The curb side of northbound Webster Avenue S., Colorado Avenue S. and Hampshire Avenue S. will also have construction between 29th Street W. and Minnetonka Boulevard.
