



NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood May – August 2017

*Text-to-subscribe for updates regarding this construction project by sending **CNP WINNETKA PIPELINE** to **468311***

- As a system upgrade project, CenterPoint Energy will be replacing natural gas transmission and distribution pipeline in Brooklyn Park along 68th and 69th Avenues N. from Adair Avenue N. to Winnetka Avenue N.
- CenterPoint Energy’s Brooklyn Park phase is expected to begin the week of May 15 and will last until early August 2017. There is a New Hope/Crystal phase that will begin in August and will last until late October 2017.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated in areas where active construction is occurring. Traffic flow will be maintained by traffic control personnel. The lane restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

Crews from CenterPoint Energy will begin replacing an existing natural gas pipeline in Brooklyn Park around May 15, 2017. Project construction is expected to last until early August. Michels Corporation, an authorized CenterPoint Energy contractor, will begin installing natural gas distribution and transmission mains along 68th and 69th Avenues N. from Adair Avenue N. westward to Winnetka Avenue N. (See map on opposite page.) (Please view CenterPointEnergy.com/Construction for weekly updates.) A New Hope/Crystal phase will begin early August 2017 on Winnetka Avenue N. southward from 68th Avenue N. to 55th Avenue N. and on 62nd Avenue N. westward from Winnetka Avenue N. to W. Broadway Avenue.

A neighborhood meeting is scheduled for April 11 from 5:00 p.m. to 7:00 p.m. at the Brooklyn Park City Hall in the Council Chambers on 5200 85th Avenue N. Representatives from the City of Brooklyn Park will attend the meeting, as well as CenterPoint Energy personnel will discuss details of the project and will invite questions or comments from the public.
