

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood May 23 – June 16, 2017

Text-to-subscribe for updates regarding this construction project by sending CNP 4STSE to 468311

- Michels Corporation, a CenterPoint Energy authorized contractor, will begin the natural gas system replacement in the Minneapolis neighborhood on 4th Street SE from 25th Avenue SE to 29th Avenue SE. Construction will take place in the areas highlighted below.
- CenterPoint Energy's construction is expected to begin on Tuesday, May 23, 2017, and will last until the week of June 12, 2017.
- Lane restrictions are anticipated in areas where active construction is occurring, but two-way traffic will be maintained on 4th Street SE, as noted on the opposite page. Traffic flow will be maintained by traffic control personnel. The lane restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy will begin replacing the natural gas system prior to the start of the City of Minneapolis's 4th Street Southeast Reconstruction Project on Tuesday, May 23. CenterPoint Energy's construction is expected to last until the week of June 12, 2017, and the affected areas are featured on the reverse side of the page. Michels Corporation, an authorized CenterPoint Energy contractor, is anticipated to begin the replacement of the existing natural gas mains on 4th Street SE from 25th Avenue SE to 29th Avenue SE.

Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe. Two-way traffic will be maintained on 4th Street SE. Traffic flow will be maintained by traffic control personnel. For the first half of the gas main installation, the crews will close the westbound lanes on 4th Street SE and reopen when the main is installed there. For the second half of the gas main installation, they will close the eastbound lanes on 4th Street SE and reopen when the main is installed there. Project updates, detailing progress and affected areas will be available at CenterPoint Energy's website at CenterPointEnergy.com/Construction.

Construction will happen in two phases: <u>Phase 1</u> consists of installing the natural gas distribution main. <u>Phase 2</u> is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
