NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood August 4 – late October 2017

- Michels Corporation, a CenterPoint Energy authorized contractor, will begin the natural gas system replacement in the Columbia Heights and Hilltop neighborhoods along Central Avenue NE (Highway 65) between 46 ½ Avenue NE and 51st Avenue NE.
- CenterPoint Energy's construction began on Friday, August 4, and will last until late October 2017.
- Construction will take place in the areas highlighted below. Lane and parking restrictions are anticipated in areas where active construction is occurring. The restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy began replacing the natural gas system on Friday, August 4. CenterPoint Energy's construction is expected to last until late October 2017, and the affected areas are featured on the reverse side of the page. Michels Corporation, an authorized CenterPoint Energy contractor, is anticipated to begin the replacement of the existing natural gas mains along Central Avenue NE (Highway 65) between 46 ½ Avenue NE and 51st Avenue NE. Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe. Project updates, detailing progress and affected areas will be available at CenterPoint Energy's website at CenterPointEnergy.com/Construction.

Construction will happen in three phases: Phase 2 consists of installing the natural gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. Phase 3 is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
