NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood July 22 – late fall 2019

- CenterPoint Energy will be replacing an existing natural gas system with modern materials in Minneapolis from the week of July 22 to late fall 2019.
- Project construction will occur in Minneapolis's Pennhurst Area. Construction will take place along selected streets between Oliver Ave. S. and Sunrise Dr. and between 54th and 58th Streets East. Work will occur in segments rather than all at once.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

From the week of July 22 to late fall 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains, connecting natural gas service lines to the installed mains, and moving any inside residential meters to the outside of homes in Minneapolis's Pennhurst Area. Construction will take place along selected streets between Oliver Ave. S. and Sunrise Dr. and between 54th and 58th Streets East. Further construction will be done by road contractors for the City of Minneapolis "Street Resurfacing Program."

Construction will happen in three phases: Phase 1 consists of installing the natural gas distribution main. Phase 2 is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. Phase 3 is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.

Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. If any closures are necessary, they will be minimized. Local access will be maintained. To sign up for weekly construction updates, please visit our website at CenterPointEnergy.com/Construction.
