

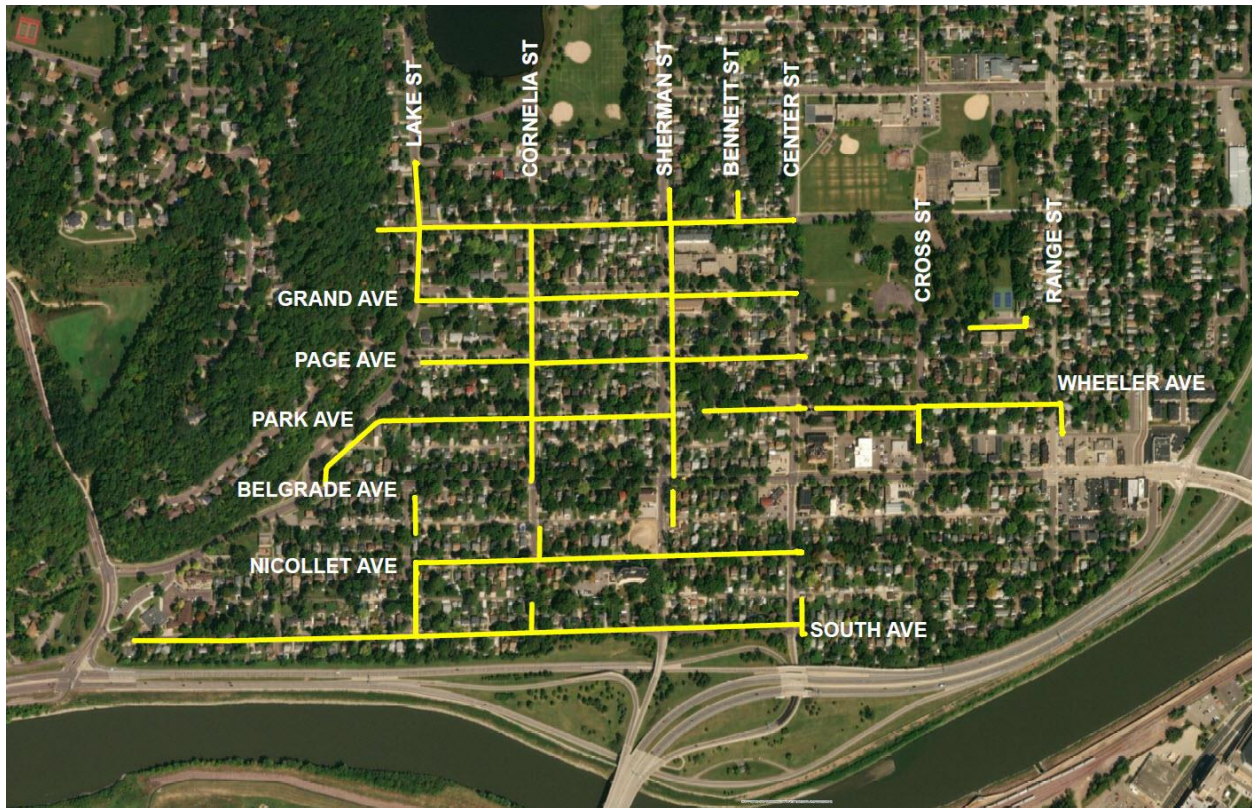

## NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood early Sept. – late fall 2019

*Text-to-subscribe for updates regarding this construction project by sending **CNP BELGRADE to 468311***

- CenterPoint Energy will be replacing an existing natural gas system with modern materials in North Mankato from early September to late fall 2019.
- Project construction will occur along selected streets between Lee Boulevard and Range Street and between Lakeview Avenue and South Avenue. Work will occur in segments rather than all at once.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

From early September to late fall 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains and connecting natural gas service lines to the installed mains in North Mankato's Belgrade Avenue Neighborhood. Construction will occur along selected streets between Lee Boulevard and Range Street and between Lakeview Avenue and South Avenue.

Construction will happen in three phases: **Phase 1** consists of installing the natural gas distribution main. **Phase 2** is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. **Phase 3** is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.

Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. If any closures are necessary, they will be minimized. Local access will be maintained.
