# NOTICE: CenterPoint Energy to upgrade natural gas Belt Line system in your neighborhood April – July 2019

- CenterPoint Energy will begin replacing the natural gas Belt Line system in the Golden Valley neighborhood in the Winnetka Avenue S. area between Western Ave. and Pennsylvania Ave. S. (See the map below.)
- CenterPoint Energy's construction will begin in April 2019 and last until July 2019.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.

Project construction will occur in the area of Winnetka Avenue S., Western Avenue, Ewald Terrace, Sumter Avenue, Wayzata Boulevard and Pennsylvania Avenue S. Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. If any closures are necessary, they will be minimized. Local access will be maintained.
