

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood April 2, 2018 – June 2018

Text-to-subscribe for updates regarding this construction project by sending CNP BROADWAYSTNE to 468311

- Michels Corporation, a CenterPoint Energy authorized contractor, will begin the natural gas system replacement in the Minneapolis neighborhood along Broadway Street NE from Industrial Boulevard NE to Johnson Street NE. (See the map below.)
- CenterPoint Energy's construction is expected to begin on Monday, April 2, and will last into June 2018. Construction will also occur in coordination with the City of Minneapolis's "Broadway Street NE" project, which will begin in Spring 2018, and "Mid-City Industrial" project, which will begin in late Spring or early Summer 2018.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe.

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood April 2, 2018 – June 2018

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities. CenterPoint Energy will begin replacing the natural gas system in Minneapolis on Monday, April 2. Project construction is expected to last into June 2018, and the affected areas are featured on the reverse side of the page. Michels Corporation, an authorized CenterPoint Energy contractor, will be replacing the existing natural gas mains along Broadway Street NE between Industrial Boulevard NE and Johnson Street NE. The crews will begin work at Industrial Boulevard NE and progress west toward Johnson Street NE. Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe. Project updates, detailing progress and affected areas will be available at CenterPoint Energy's website at CenterPointEnergy.com/Construction.

Construction will also occur in coordination with the City of Minneapolis's "Broadway Street NE" project, which will begin in Spring 2018, and "Mid-City Industrial" project, which will begin in late Spring or early Summer 2018. Construction will happen in three phases: Phase 1 consists of installing the natural gas distribution main. Phase 2 is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. Phase 3 is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
