

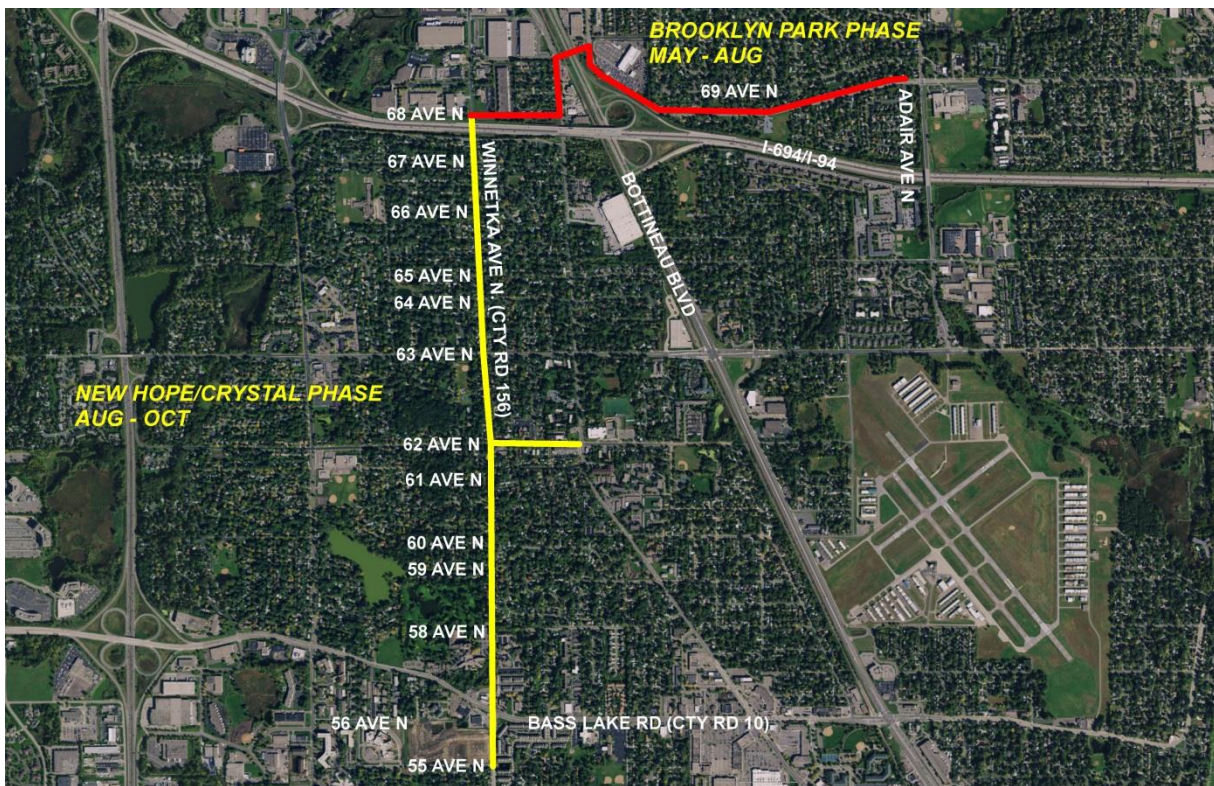

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood August – October 2017

*Text-to-subscribe for updates regarding this construction project by sending **CNP WINNETKA PIPELINE** to 468311*

- As a system upgrade project, CenterPoint Energy will be replacing natural gas transmission and distribution pipeline in the New Hope and Crystal neighborhoods along Winnetka Avenue N. from 68th Avenue N. (Brooklyn Park) to 55th Avenue N.
- CenterPoint Energy's construction is expected to begin the week of August 7 and will last until late October 2017.
- Construction will take place in the areas highlighted below. There will be anticipated full-lane closures on Winnetka Avenue N. that will allow access to local traffic only. The lane closures will occur as pipeline construction progresses to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

An open house is scheduled for April 3 at 6:00 p.m. at the New Hope City Hall 4401 Xylon Avenue N. Representatives from the Cities of New Hope and Crystal as well as CenterPoint Energy personnel will discuss details of the project and will then invite questions or comments from the public.

Crews from CenterPoint Energy will begin replacing an existing natural gas pipeline in New Hope and Crystal around August 7, 2017. Project construction is expected to last until late October. Michels Corporation, an authorized CenterPoint Energy contractor, will begin installing natural gas distribution and transmission mains along Winnetka Avenue N. from 68th Avenue N. just north of I-694/I-94 in Brooklyn Park to 55th Avenue N. in New Hope. (See map on opposite page.) Winnetka Avenue N. will allow access to local traffic only in areas of pipeline construction activity (typically two to three blocks at a time).
