- From Wednesday, June 5, to early July, CenterPoint Energy's authorized contractor, Minnesota Limited, will close Ewald Ter. from Winnetka Ave. N. to Sumter Ave. N. and Sumter Ave. N. from Ewald Ter. to Wayzata Blvd. to through traffic. During this time the crews will be milling the road, installing the natural gas main, and restoring the areas affected by their construction.
- Although parking will be obstructed on both sides of the affected roads, residents can access
 their driveways. Eastbound and westbound traffic on Ridgeway Rd. and Laurel Ave. will remain
 open for most of the project's duration. When the crews cross these streets, they will close one
 street at a time. Each closure will last approximately a few business days. These closures are
