- Due to the crews' progress and agreements with Golden Valley, CenterPoint Energy's authorized contractor, Minnesota Limited, will be returning to the following areas in Sept. and Oct.: Ewald Ter. from Sumter Ave. S. to Winnetka Ave. S.; Winnetka Ave. S. between Ewald Ter. and Western Ave.; and the intersection of Texas Ave. S. and the south frontage road of Wayzata Blvd.
- For approx. 4 weeks the crews will be on Ewald Ter. and Winnetka Ave. For approx. 3 weeks the crews will be on Texas Ave. S. and Wayzata Blvd. During this time the crews will be installing natural gas main and restoring the areas affected by their construction.
- Detour signs will be posted for any closures. These closures are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

Due to the crews' progress and agreements between CenterPoint Energy and the City of Golden Valley, CenterPoint Energy is delaying some of its construction for the Golden Valley 2019 Belt Line Project. When they resume construction, they will be installing the last of the project's natural gas main and restoring the areas affected by their construction. Any closures are necessary to keep both the public and construction personnel safe:

- For approximately four weeks beginning in mid- or late September or early October, CenterPoint Energy's authorized contractor, Minnesota Limited, will close the following areas: Ewald Terrace from Sumter Avenue S. to Winnetka Avenue S., and Winnetka Avenue S. between Ewald Terrace and Western Avenue. Detour signs will be on site. Residents will have access to and from their driveways.
- For approximately three weeks beginning in mid- or late September or early October, the crews will close the intersection of Texas Avenue S. and the south frontage road of Wayzata Boulevard. Detour signs will be on site.

More details will be posted on CenterPoint Energy's Construction Zone website closer to the project's timeline. We appreciate your patience as we continue the construction process.
