 1 to mid-June 2019. The inspection work will be supported by authorized contractors Michels
 Corporation and Rosen Company.
- The affected areas will include the following: Osborne Road NE just east of East River Road; the southwest baseball field of Fridley's Community Park by Rice Creek West Regional Trail; and East River Road between 62nd Way NE and 63rd Way NE.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe.

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy will be performing routine inspection on its pipeline in Fridley from April 1 to mid-June. The inspection work will be supported by authorized contractors Michels Corporation and Rosen Company. They will be in the following areas:

- Osborne Road NE just east of East River Road: From April 1 to May 1, the crews will be closing the eastbound right lane on Osborne Road.
- The southwest baseball field of Fridley's Community Park by Rice Creek West Regional Trail: From April 1 to mid-June, the southwest baseball field will be fenced off. The crews will be transporting their equipment via Commerce Cir. W. and the service road near the railroad.
- East River Road between 62nd Way NE and 63rd Way NE: From April 1 to mid-June, the crews will be closing the southbound right lane and shoulder of East River Road in this area. In addition, there will be a lane shift on 62nd Way NE west of East River Road.

The City of Fridley has approved the usage of our equipment in these areas. Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe.
