NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood May 20 – late July 2019

- From the week of May 20 to late July 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains and connecting natural gas service lines to the installed mains in Lakeville within the Oak Shore Drive neighborhood.
- Project construction will occur along selected streets between Maple Island Road and 162nd Street W. (See our map below.) Work will occur in segments rather than all at once.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.
- CenterPoint Energy's authorized contractor will restore the areas affected by our work outside the city construction zone—typically the boulevard, sidewalks and lawns.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

From the week of May 20 to late July 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains and connecting natural gas service lines to the installed mains in Lakeville within the Oak Shore Drive neighborhood. CenterPoint Energy's work will be done in coordination with the City of Lakeville's "[2019 Street Reconstruction Project](#)." For more information on the city's project, please visit its website.

Construction will happen in three phases: **Phase 1** consists of installing the natural gas distribution main. **Phase 2** is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the new gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. **Phase 3** is the restoration of disturbed areas affected by our work outside the city construction zone—typically the boulevard, sidewalks and lawns.

Work will occur in segments rather than all at once. Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
