

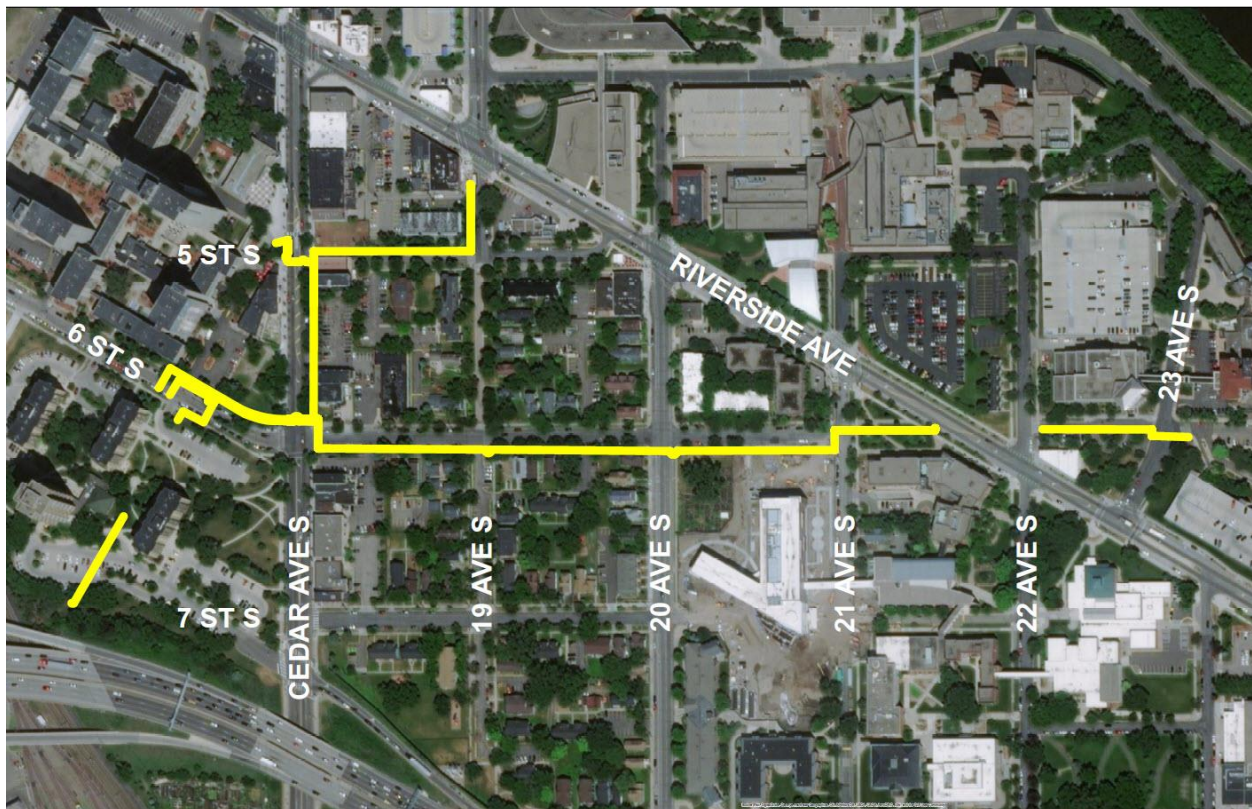

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood July 22 – early fall 2019

*Text-to-subscribe for updates regarding this construction project by sending **CNP 6STSOUTH to 468311***

- From the week of July 22 to early fall 2019, CenterPoint Energy will replace existing natural gas distribution mains with modern materials, connect natural gas service lines to the installed mains, and move inside residential meters to outside of homes in Minneapolis.
- Construction will take place along 6th St. S. from Cedar Ave. S. to 23rd Ave. S.; Cedar Ave. S. from 5th to 6th Streets S.; and 5th St. S. from Cedar Ave. S. to 19th Ave. S. Work will occur in segments rather than all at once.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

From the week of July 22 to early fall 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains in Minneapolis. Construction will take place along 6th Street S. from Cedar Avenue S. to 23rd Avenue S.; Cedar Avenue S. from 5th to 6th Streets S.; and 5th Street S. from Cedar Avenue S. to 19th Avenue S. Please see our map of construction on the opposite page.

Construction will happen in two phases: **Phase 1** consists of installing the natural gas distribution main. **Phase 2** is the restoration of disturbed areas affected by our work outside the city construction zone—typically the boulevard, sidewalks and lawns. Further construction will be done by the City of Minneapolis for the city's "[U of M Protected Bikeways](#)" project and "[Street Resurfacing Program](#)." Work will occur in segments rather than all at once. Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
