

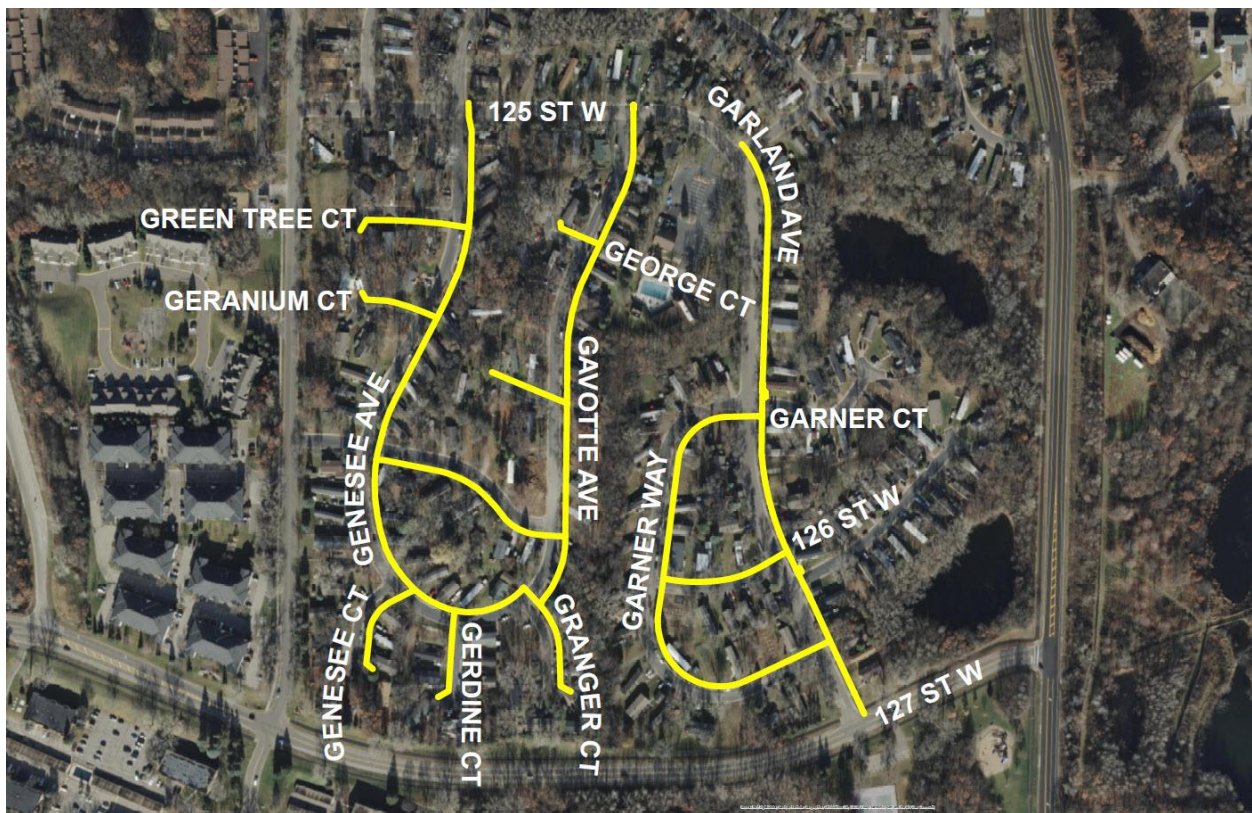

CenterPoint Energy will upgrade natural gas pipelines in Apple Valley from July 8 to early fall 2019

- From the week of July 8 to early fall 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will replace natural gas pipelines in Apple Valley.
- Project construction will occur along selected streets in the Cedar Knolls neighborhood. Work will occur in segments rather than all at once.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If closures are necessary, they will be minimized. Local access will be maintained.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

From the week of July 8 to early fall 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains and connecting natural gas service lines to the installed mains in Apple Valley along selected streets in the Cedar Knolls neighborhood. Work will occur in segments rather than all at once.

Construction will happen in three phases: **Phase 1** consists of installing the natural gas distribution main. **Phase 2** is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. **Phase 3** is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.

Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. If any closures are necessary, they will be minimized. Local access will be maintained. To sign up for weekly construction updates, please visit our website at CenterPointEnergy.com/Construction.
