- Michels Corporation, an authorized CenterPoint Energy contractor, will replace the natural gas system in the Edina neighborhood along selected streets between Ewing and York Avenues S. and between 58th and 60th Streets West.
- CenterPoint Energy's construction is expected to begin the week of April 15, 2019, and will last until late July 2019.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities. From the week of April 15 to late July 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains and connecting natural gas service lines to the installed mains in Edina in the Abbot Avenue S. and 59th Street West neighborhood. Further construction will be done by contractors for the City of Edina for the city's "[Chowen Park A & B Roadway Reconstruction](#)." Nearby construction by the city will involve the "[West 58th Street Reconstruction](#)" project. For more information on the city's project, please visit its website. Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe. Construction will happen in three phases: **Phase 1** consists of installing the natural gas distribution main. **Phase 2** is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. **Phase 3** is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
