

## NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood April 8 – early June 2019

## Text-to-subscribe for updates regarding this construction project by sending CNP DECATUR to 468311

- Michels Corporation, an authorized CenterPoint Energy contractor, will replace the natural gas system in the Golden Valley neighborhood along Ensign Ave. N., Decatur Ave. N., Cavell Ave. N. and Brogger Cir. between Medicine Lake Rd. and Elgin Pl.
- CenterPoint Energy's construction is expected to begin the week of April 8, 2019, and will last until early June 2019.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

From the week of April 8 to early June 2019, CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing natural gas mains and connecting natural gas service lines to the installed mains in Golden Valley in the Decatur Avenue N. neighborhood. Further construction will be done by contractors for the City of Golden Valley for the city's "2019 Pavement Management Program." For more information on the city's project, please visit its website. Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe. Construction will happen in three phases: <a href="Phase 1">Phase 1</a> consists of installing the natural gas distribution main. <a href="Phase 2">Phase 2</a> is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. <a href="Phase 3">Phase 3</a> is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
