

- Minnesota Limited, an authorized CenterPoint Energy contractor, will replace the natural gas system in the Minneapolis neighborhood along 24th Ave. N. between Washington Ave. N. and 2nd St. N., and also between 3rd St. N. and a block west of Fremont Ave. N.
- CenterPoint Energy's construction is expected to begin on Monday, October 8, and last until mid-December 2018.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy's authorized contractor, Minnesota Limited, will be replacing the natural gas system in the Minneapolis neighborhood along 24th Ave. N. between Washington Ave. N. and 2nd St. N., and also between 3rd St. N. and a block west of Fremont Ave. N. Construction is expected to begin on Monday, October 8, and last until mid-December 2018. Local businesses and residents will have access to their properties. As one to two block segments of 24th Avenue N. are affected by active construction, detour signs will be posted. As the crews will progress along 24th Avenue N., one or two of the intersections will be closed at a time and then reopened. Each closure will last from one to five business days to allow for the pipeline replacement. Detour signs will be posted. Metro Transit's bus stops may be moved one or two blocks away from the route during construction; then they will be relocated back to their original stops when the closures are lifted. Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe.

Construction will happen in two phases: <u>Phase 1</u> consists of installing the natural gas distribution main. <u>Phase 2</u> is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of soft surface restoration and sidewalk or street restoration as work dictates.
