

NOTICE: CenterPoint Energy to upgrade natural gas system in your neighborhood in Dec. & April 2018

Text-to-subscribe for updates regarding this construction project by sending CNP DIAMONDLAKE to 468311

- In coordination with the City of Minneapolis, CenterPoint Energy will begin replacing the natural gas system in the Minneapolis neighborhood along Portland Avenue S. between E. 56th Street and E. 60th Street. (See the map below.)
- CenterPoint Energy's construction will begin on Monday, December 10; continue through the end of December 2018 or January 2019; and resume in April 2019.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- Two-way traffic will be maintained. No full road closures are anticipated for this project.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing a natural gas main and connecting natural gas service lines to the installed main along the east side of Portland Ave. S. between E. 56th St. and E. 60th St. The work will begin on Monday, December 10; continue through the end of December 2018 or January 2019; and resume in April 2019. Crews from Q3 Contracting, an authorized CenterPoint Energy contractor, will temporarily restore the hard and soft surfaces affected by Michels Corporation's construction. Q3 Contracting will return in the spring and summer 2019 construction season to permanently restore these areas. Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. Two-way traffic will be maintained. This project is in preparation for CenterPoint Energy's Minneapolis 2019 Belt Line Project, which is a continuation of CenterPoint Energy's Belt Line Project in Minnesota. The entire Belt Line Project began in 2012 and will continue until approximately 2022. The Belt Line system is a series of natural gas distribution mains along routes from Brooklyn Center to Bloomington and from Golden Valley to Minneapolis.
