

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood April 8 – mid-June 2019

- CenterPoint Energy will be replacing an existing natural gas distribution main with modern materials in Minneapolis from the week of April 8 to the middle of June 2019.
- Project construction will occur along these streets in Minneapolis: McNair Ave. N. between Glenwood Pkwy and Russell Ave. N.; 23rd Ave. N. between McNair Ave. N. and the alley between Queen Ave. N. and Penn Ave. N.; Glenwood Pkwy between Golden Valley Road and McNair Ave. N. Work will occur in 2- to 3-block segments at a time.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy will be replacing an existing natural gas distribution main with modern materials in Minneapolis from the week of April 8 to the middle of June 2019. Project construction will occur along these streets: McNair Ave. N. between Glenwood Pkwy and Russell Ave. N.; 23rd Ave. N. between McNair Ave. N. and the alley between Queen Ave. N. and Penn Ave. N.; Glenwood Pkwy between Golden Valley Road and McNair Ave. N. Work will occur in 2- to 3-block segments at a time.

Construction will happen in two phases: Phase 1 consists of installing the natural gas distribution main. Phase 2 is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.

Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
