

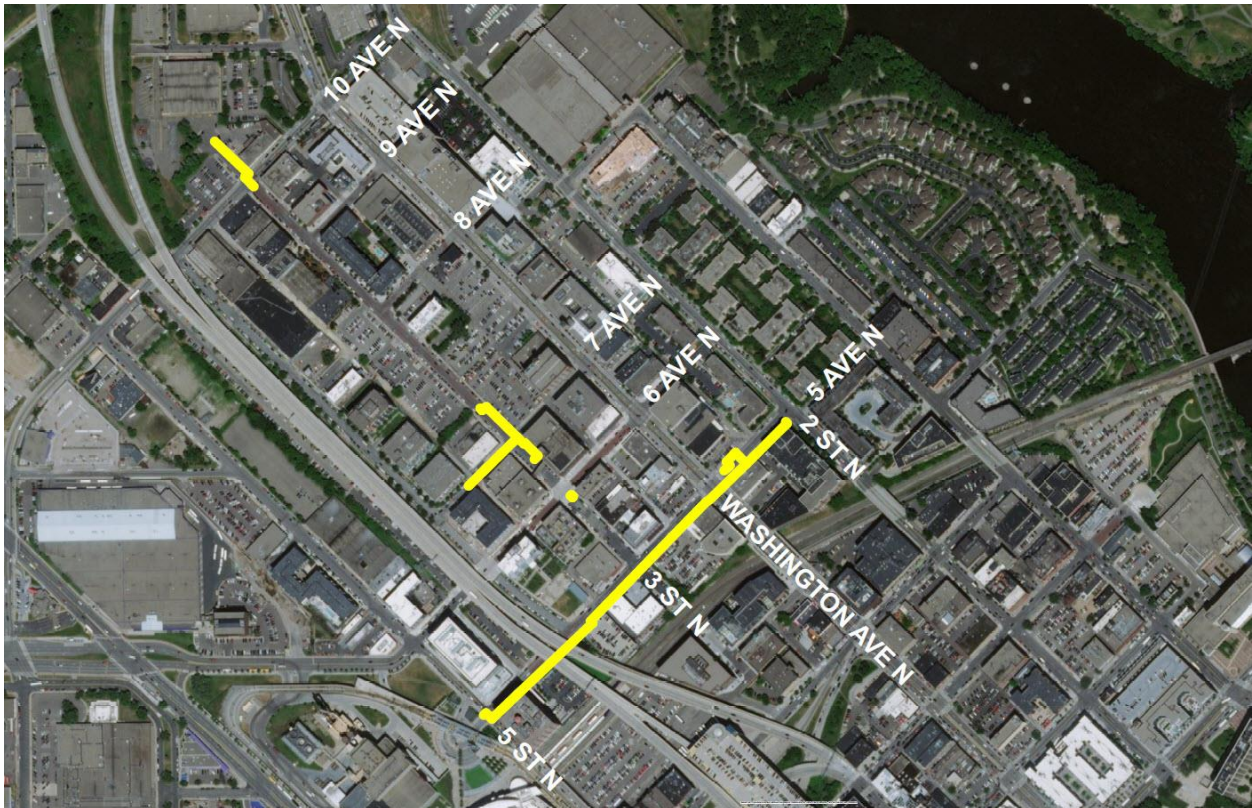

## NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood May 6 – late June 2019

- CenterPoint Energy will be replacing an existing natural gas distribution main with modern materials in Minneapolis from May 6 to late June 2019.
- Project construction will occur along selected streets such as 5<sup>th</sup> Ave. N. between 2<sup>nd</sup> and 5<sup>th</sup> Streets N.; 3<sup>rd</sup> St. N. at 7<sup>th</sup> and 10<sup>th</sup> Avenues N.; and 7<sup>th</sup> Ave. N. between 3<sup>rd</sup> St. N. and the alley between 3<sup>rd</sup> and 4<sup>th</sup> Streets N. Work will occur in segments rather than all at once.
- Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.
- Further construction will be done by contractors for the City of Minneapolis for the city's "[North Loop Paving Project](#)."

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy will be replacing an existing natural gas distribution main with modern materials in Minneapolis from Monday, May 6, to late June 2019. Project construction will occur along streets such as 5<sup>th</sup> Ave. N. between 2<sup>nd</sup> and 5<sup>th</sup> Streets N.; 3<sup>rd</sup> St. N. at 7<sup>th</sup> and 10<sup>th</sup> Avenues N.; and 7<sup>th</sup> Ave. N. between 3<sup>rd</sup> St. N. and the alley between 3<sup>rd</sup> and 4<sup>th</sup> Streets N. Work will occur in segments rather than all at once. Further construction will be done by contractors for the City of Minneapolis for the city's "[North Loop Paving Project](#)."

Construction will happen in three phases: **Phase 1** consists of installing the natural gas distribution main. **Phase 2** is connecting the individual customer gas service lines to the new gas distribution main. This may include service line replacement. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. **Phase 3** is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates. The city will restore the areas affected by its work.

Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. If any closures are necessary, they will be minimized. Local access will be maintained.
