

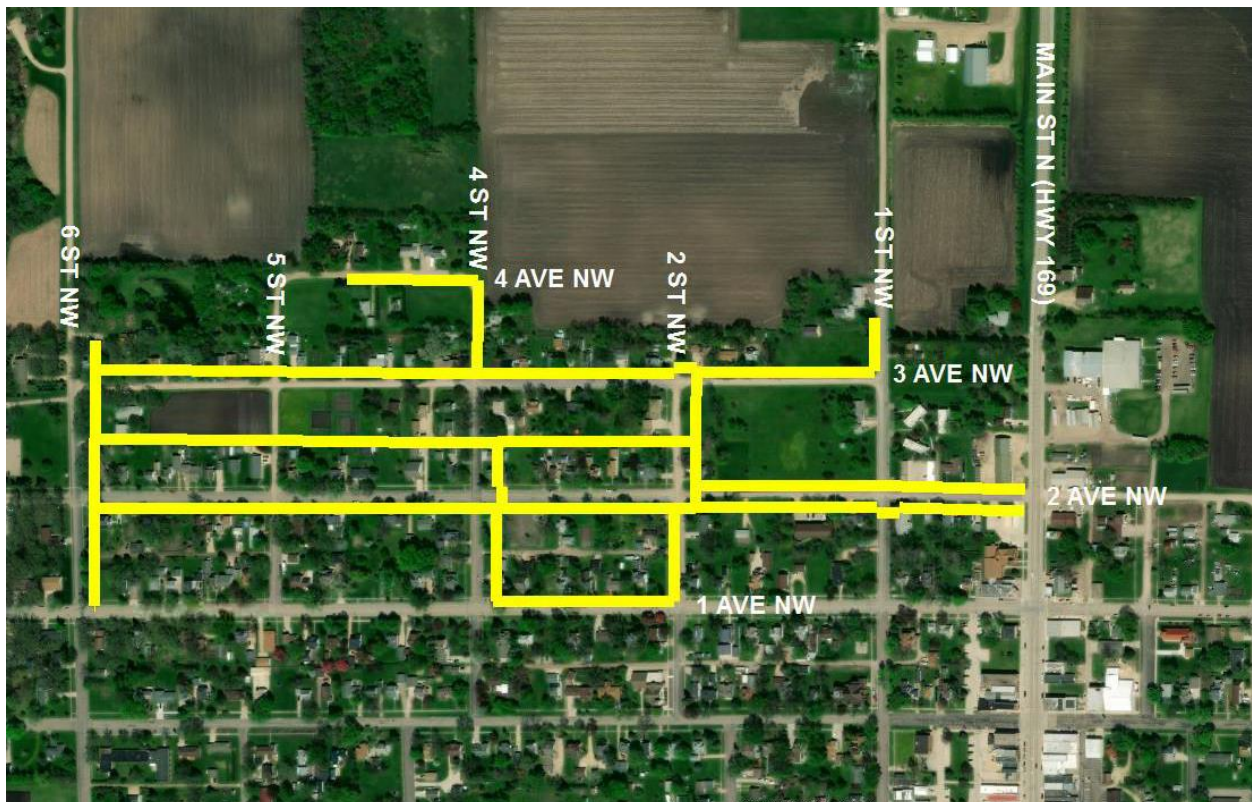

## NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood beginning week of April 29, 2019

*Text-to-subscribe for updates regarding this construction project by sending **CNP 2AVENW2019 to 468311***

- CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing existing natural gas distribution mains with modern materials in Winnebago. Concurrent construction will be done by contractors for the City of Winnebago's project.
- The first half of CenterPoint Energy's project will begin in the week of April 29, last for approx. four weeks, and occur on selected streets east of 4<sup>th</sup> St. NW. The second half of our project will occur on selected streets west of 4<sup>th</sup> St. NW. The second half's start date will be coordinated with the city.
- Work will occur in segments rather than all at once. Lane restrictions and road closures are anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe.
- If any closures are necessary, they will be minimized. Local access will be maintained.

## **NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood beginning week of April 29, 2019**

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

CenterPoint Energy's authorized contractor, Michels Corporation, will be replacing an existing natural gas distribution main with modern materials in Winnebago and coordinating with the City of Winnebago. The project will occur in two parts. The first half will begin in the week of April 29 and last for approximately four weeks. It will involve Michels Corporation's installing natural gas distribution mains and connecting natural gas service lines to the installed mains along selected streets between 4<sup>th</sup> St. NW and Main St. (Hwy 169). (Service line connections may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. CenterPoint Energy crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement.) The city will be restoring the areas affected by construction.

The second half will involve Michels Corporation's installing natural gas mains and connecting natural gas service lines to the installed mains along selected streets between 4<sup>th</sup> St. NW and 6<sup>th</sup> St. NW. The start date for the second half is to be determined with the city.

Lane restrictions will be anticipated in areas where active construction is occurring and are necessary to keep both the public and construction personnel safe. If any closures are necessary, they will be minimized. Local access will be maintained.
