

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

Crews from Michels Corporation and Construction & Maintenance, authorized contractors for CenterPoint Energy, will be performing a routine maintenance on the transmission pipe located along Nicollet Avenue S. between W. 82nd Street and W. 98th Street in Bloomington. The process will begin in early September after Labor Day and last until approximately mid-October. The process, called pigging, will involve the crews placing tools every 1,000 feet along the pipe to inspect the pipe's condition. Per federal regulation, CenterPoint Energy is required to check the condition of its pipes routinely.

Since the pipe runs underneath Nicollet Avenue S., the crews will put traffic control in place starting after Labor Day. CenterPoint Energy will send updates regarding the progress of the maintenance and traffic control. During the maintenance, residential driveways will remain open, and the homes' gas lines will remain active. CenterPoint Energy wants to thank you for your patience.
