

- As a system upgrade project, Michels Corporation, a CenterPoint Energy authorized contractor, will be installing 9,000' of 8" natural gas distribution pipe in the Hastings neighborhood west of W. 31st Street and east of Jorgen Avenue (County Road 47).
- CenterPoint Energy's construction is expected to start in late July and will last approximately into the month of September 2016.
- Construction will take place in the areas highlighted below. Several sidewalks will be closed during limited times before they're reopened, as noted on our website.

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

Michels Corporation, an authorized CenterPoint Energy contractor, will be installing about 9,000' of 8" natural gas distribution main in the neighborhood west of W. 31st Street and east of Jorgen Avenue (County Road 47) in Hastings (see map for detail). Construction is expected to start in late July and will last approximately into the month of September 2016. The areas disturbed by our construction activity will be restored in compliance with all federal, state and local regulations.

The affected streets will include the following: W. 31st Street, Cannon Street, Lester Avenue, Leroy Avenue, Olson Drive, Highview Drive, Highview Knoll, Bohlken Drive, Riverwood Drive, Teal Way, Village Trail, Sherman Way, Union Court, and Jorgen Avenue (County Road 47). Some lanes and sidewalks will be alternately closed for limited times during construction before they're reopened.
