



## **NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood occurring in late July, early August 2016**

- As a system upgrade project, Michels Corporation, a CenterPoint Energy authorized contractor, will be performing two 5-foot cutouts of steel transmission pipe in the Lakeville neighborhood on Jarl Court east of Kenwood Trail and Interstate 35.
- CenterPoint Energy's construction is expected to begin the week of July 25, 2016. Construction will happen in two phases, which last for 3-5 days each.
- Construction will take place in the areas highlighted below. Each lane on Jarl Court will be closed alternately during limited times, as noted on our website.

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

Michels Corporation, an authorized CenterPoint Energy contractor, will be performing two 5-foot cutouts of steel transmission pipe in the Jarl Court neighborhood east of Kenwood Trail and Interstate 35 in Lakeville (see map for detail). Construction is expected to begin in the week of July 25, 2016, and will require two phases that are approximately 3-5 days each. The areas disturbed by our construction activity will be restored in compliance with all federal, state and local regulations.

The affected areas will include the cul-de-sac in Jarl Court and the open area south of Jarl Court. Some lanes will be closed for limited times during construction, but crews will provide temporary access for residents in the Jarl Court cul-de-sac.
