



NOTICE: CenterPoint Energy to Upgrade Natural Gas Pipelines in Your Neighborhood Late May to Early June 2015

- In preparation for an Anoka County paving project, CenterPoint Energy will be replacing 2.3 miles of 2-inch, 3-inch, 4-inch, 6-inch and 8-inch steel and iron pipe with plastic pipe and replacing approximately 140 natural gas service lines.
- CenterPoint Energy's construction is anticipated to start in late May to early June 2015 and will require approximately two and a half months to complete the work.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

In preparation for an Anoka County paving project, Michels Corporation, an authorized CenterPoint Energy contractor, will be replacing 2.3 miles of 2-inch, 3-inch, 4-inch, 6-inch and 8-inch steel and iron pipe with plastic pipe along Reservoir Boulevard, from just south of Gould Avenue NE to Stinson Boulevard (see map for detail). Construction is expected to begin in late May to early June 2015 and will require approximately two and a half months to complete the work. We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.

The work will also include the replacement of approximately 140 natural gas service lines. Representatives from CenterPoint Energy will contact residents whose gas service may be affected to schedule the necessary construction work on their property. In addition, your gas meter will be evaluated and replaced if necessary. If the gas meter is located inside your home or building, we will move it to an outside location.

CenterPoint Energy has provided safe, clean and efficient natural gas service to Minnesota communities for more than 140 years. We are proud of this record and strive to improve it by educating the public about the benefits of natural gas and how to use it safely and efficiently.
