



## NOTICE: CenterPoint Energy to Upgrade Natural Gas Pipelines in Your Neighborhood Late March 2015

- In preparation for the city of Lakeville's reconstruction project, CenterPoint Energy will be installing approximately 6.7 miles of natural gas distribution pipe and replacing approximately 465 natural gas service lines.
- CenterPoint Energy's construction is anticipated to start in late March 2015 and is expected to be completed by early July 2015.
- Construction will take place within Lakeville's first reconstruction phase. **Please anticipate potential parking lane closures as construction progresses.**

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

In preparation for the city of Lakeville's reconstruction project, Michels Corporation, an authorized CenterPoint Energy contractor, will install approximately 6.7 miles of natural gas distribution pipe within Lakeville's first reconstruction phase (see map for detail). Construction is expected to begin in late March 2015 and will be completed by early July 2015. **Please anticipate potential parking lane closures as construction progresses.** We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.

The work will also include the replacement of approximately 465 natural gas service lines. Representatives from CenterPoint Energy will contact residents whose gas service may be affected to schedule the necessary construction work on their property. In addition, your gas meter will be evaluated and replaced if necessary. If the gas meter is located inside your home or building, we will move it to an outside location.
