

NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood September 25 – early winter 2017

- Michels Corporation, a CenterPoint Energy authorized contractor, will begin the natural gas system replacement in the Minneapolis neighborhood along E. 25th Street between 13th Avenue S. and 14th Avenue S.
- CenterPoint Energy's construction is expected to begin the week of September 25, 2017, and will last into December 2017 with permanent restoration of hard and soft surfaces taking place in the spring. The affected roads and sidewalks will be open for drivers and pedestrians to use.
- Construction will take place in the areas highlighted below. Lane restrictions are anticipated
 in areas where active construction is occurring. The lane restrictions are necessary to keep both
 the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

Crews from CenterPoint Energy will begin replacing an existing natural gas pipeline in Minneapolis the week of September 25, 2017. Project construction is expected to last into December 2017 with permanent restoration of hard and soft surfaces taking place in the spring. The affected roads and sidewalks will be open for drivers and pedestrians to use. Project updates of the affected areas will be available at CenterPoint Energy's website at CenterPoint Energy's website at CenterPoint Energy contractor, will begin installing natural gas mains along E. 25th Street between 13th Avenue S. and 14th Avenue S. (See map on the opposite page.)

Lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe. Below are the following traffic plans:

- There will be periodic closures on E. 25th Street between 13th Avenue S. and 14th Avenue S. At alternate times, there will be periodic closures on either 13th Avenue S. or 14th Avenue S.
- During a closure, detour signs will be posted on site. The signs will be changed alternately to correspond with the above closures: E. 24th Street, Bloomington Avenue, E. 26th Street, 12th Avenue S. and Chicago Avenue.

Construction will happen in two phases: <u>Phase 1</u> consists of installing the natural gas distribution main. <u>Phase 2</u> is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
