

## NOTICE: CenterPoint Energy to upgrade natural gas pipelines in your neighborhood September 11 – late October 2017

## Text-to-subscribe for updates regarding this construction project by sending CNP 22STINSON to 468311

- Michels Corporation, a CenterPoint Energy authorized contractor, will begin the natural gas system replacement in the Minneapolis neighborhood between the following streets: 22<sup>nd</sup> Avenue NE, 23<sup>rd</sup> Avenue NE, Stinson Parkway NE, and Wilson Street NE.
- CenterPoint Energy's construction began the week of September 11, 2017, and will last until the end of October 2017.
- Construction will take place in the areas highlighted below. Parking and lane restrictions are anticipated in areas where active construction is occurring. The lane restrictions are necessary to keep both the public and construction personnel safe.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities. Crews from CenterPoint Energy will begin replacing an existing natural gas pipeline in Minneapolis the week of September 11, 2017. Project construction is expected to last up to seven weeks. Michels Corporation, an authorized CenterPoint Energy contractor, will begin installing natural gas mains along the following streets: (see map on the opposite page):

- 22nd Avenue NE between Stinson Parkway and Wilson Street NE
- Stinson Parkway between 22nd Avenue NE and 23rd Avenue NE
- Roosevelt Street NE between 22nd Avenue NE and 23rd Avenue NE
- Taft Street NE between 22nd Avenue NE and 23rd Avenue NE
- Wilson Street NE between 22nd Avenue NE and 23rd Avenue NE

Parking and lane restrictions are required in areas where construction activity is occurring and is necessary to keep both the public and construction personnel safe. Project updates, detailing progress and affected areas will be available at CenterPoint Energy's website at CenterPointEnergy.com/Construction.

Construction will happen in three phases: <a href="Phase 1">Phase 2</a> consists of installing the natural gas distribution main. This may include service line replacement and relocating gas meters from inside the home to outside. Customers will experience a short disruption of gas service as the crews are installing the gas service line. Crews may have to dig in the ground on your property in the utility easement to complete the task of service and main distribution line replacement. <a href="Phase 3">Phase 3</a> is the restoration of disturbed areas affected by our work outside the city construction zone. This may consist of lawn restoration and sidewalk or street restoration as work dictates.
