

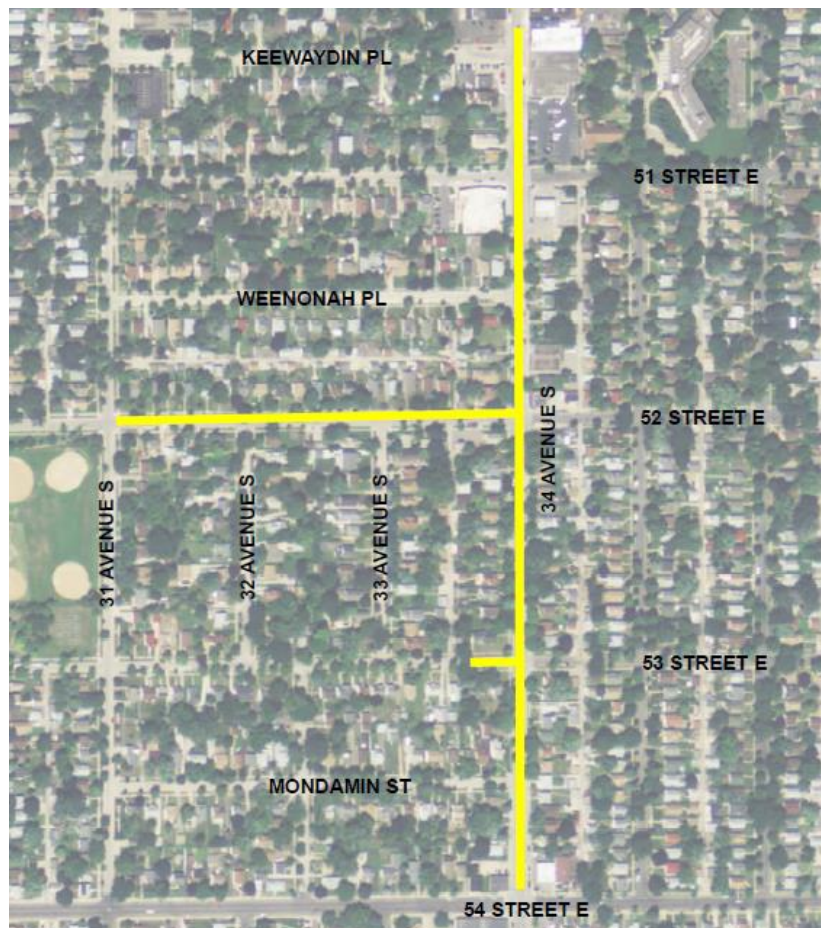

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

As a system upgrade project, Michels Corporation, an authorized CenterPoint Energy contractor, will be replacing approximately 2,430 feet of 8-inch steel pipe with 3,680 feet of 2-inch and 3-inch plastic pipe along 34<sup>th</sup> Avenue S., from 54<sup>th</sup> Street E. to Keewaydin Place and along 52<sup>nd</sup> Street E., from 34<sup>th</sup> Avenue S. to 31<sup>st</sup> Avenue S (see map for detail). Construction is expected to begin on September 3, 2015 and will require two months to complete the work. We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.

The work will also include the replacement of approximately 90 natural gas service lines. Representatives from CenterPoint Energy will contact residents whose gas service may be affected to schedule the necessary construction work on their property. In addition, your gas meter will be evaluated and replaced if necessary. If the gas meter is located inside your home or building, we will move it to an outside location.

CenterPoint Energy has provided safe, clean and efficient natural gas service to Minnesota communities for more than 140 years. We are proud of this record and strive to improve it by educating the public about the benefits of natural gas and how to use it safely and efficiently.
