- As a system upgrade project, CenterPoint Energy will replace approximately 800 feet of 24-inch steel pipe with 1,000 feet of 24-inch steel pipe as well as some minor replacement of smaller diameter pipe and replace approximately 1 natural gas service line.
- CenterPoint Energy's construction is anticipated to start the week of July 27, 2015 and will require approximately one month to complete the work.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

As a system upgrade paving project, Michels Corporation, an authorized CenterPoint Energy contractor, will be replacing approximately 800 feet of 24-inch steel pipe with 1,000 feet of 24-inch steel pipe as well as some minor replacement of smaller diameter pipe along Anderson Lane, from 10 Avenue S. to 12 Avenue S. and along 12 Avenue S., from Anderson Lane to 27 Street E. A short section of work will also take place north of Anderson United Community School, along 27 Street E (see map for detail). Construction is expected to begin the week of July 27, 2015 and will require one month to complete the work. We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.

The work will also include the replacement of approximately 1 natural gas service line. Representatives from CenterPoint Energy will contact residents whose gas service may be affected to schedule the necessary construction work on their property. In addition, your gas meter will be evaluated and replaced if necessary. If the gas meter is located inside your home or building, we will move it to an outside location.

CenterPoint Energy has provided safe, clean and efficient natural gas service to Minnesota communities for more than 140 years. We are proud of this record and strive to improve it by educating the public about the benefits of natural gas and how to use it safely and efficiently.
