in your neighborhood the week of September 28, 2015**

- As a system upgrade project, CenterPoint Energy will replace approximately 1,365 feet of various steel and plastic pipe with 2,680 feet of 2-inch, 6-inch and 8-inch plastic pipe and 20-inch steel pipe and replace approximately 40 natural gas service lines.
- CenterPoint Energy's construction is anticipated to start the week of September 28, 2015 and will require approximately two months to complete the work.
- **Please anticipate a full road closure of Emerson Avenue S. for one and a half months. Traffic will be open to local residents only to access driveways.**

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

As a system upgrade project, Michels Corporation, an authorized CenterPoint Energy contractor, will be replacing approximately 1,365 feet of various steel and plastic pipe with 2,680 feet of 2-inch, 6-inch and 8-inch plastic pipe and 20-inch steel pipe along Emerson Avenue S., from Douglas Avenue to Franklin Avenue W (see map for detail). **Please anticipate a full road closure of Emerson Avenue S. for one and a half months. Traffic will be open to local residents only to access driveways.** Construction is expected to begin the week of September 28, 2015 and will require two months to complete the work. We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.

The work will also include the replacement of approximately 40 natural gas service lines. Representatives from CenterPoint Energy will contact residents whose gas service may be affected to schedule the necessary construction work on their property. In addition, your gas meter will be evaluated and replaced if necessary. If the gas meter is located inside your home or building, we will move it to an outside location.
