- As a system upgrade project, CenterPoint Energy will replace approximately 750 feet of 2-inch, 4-inch and 6-inch steel and plastic pipe with approximately 800 feet of 4-inch plastic pipe and replace approximately 30 natural gas service lines along Harriet Avenue S., from 55<sup>th</sup> Street W. to 56<sup>th</sup> Street W.
- CenterPoint Energy's construction is anticipated to begin in mid-November of 2015 and will require approximately three weeks to complete the work.

Dear Property Owner,

At CenterPoint Energy, we are committed to providing timely and relevant information to our customers and the general public to minimize inconvenience or disruption due to our construction activities.

As a system upgrade project, Michels Corporation, an authorized CenterPoint Energy contractor, will be replacing approximately 750 feet of 2-inch, 4-inch and 6-inch steel and plastic pipe with approximately 800 feet of 4-inch plastic pipe along Harriet Avenue S., from 55<sup>th</sup> Street W. to 56<sup>th</sup> Street W (see map for detail). Construction is expected to begin in mid- November of 2015 and will require approximately three weeks to complete the work. We will restore the areas affected by our construction in compliance with all applicable federal, state and local regulations.

The work will also include the replacement of approximately 30 natural gas service lines. Representatives from CenterPoint Energy will contact residents whose gas service may be affected to schedule the necessary construction work on their property. In addition, your gas meter will be evaluated and replaced if necessary. If the gas meter is located inside your home or building, we will move it to an outside location.
