**SHORT DESCRIPTION:** On August 12, 2018, CenterPoint Energy will replace the 3-digit numeric and alpha Rate Class descriptors for IDR and Streetlight accounts on several Tx SET transactions with a longer narrative rate description that corresponds to the tariff rate for the ESI-ID.

**INTENDED AUDIENCE:** All Market Participants

**LONG DESCRIPTION:** On August 12, 2018, CenterPoint Energy will replace the 3-digit numeric and alpha Rate Class descriptors for IDR and Streetlight accounts on several Tx SET transactions with a longer narrative rate description that corresponds to the tariff rate for the ESI-ID. These changes will be reflected in the following Texas SET transactions:

- **810\_02** TDSP Invoice
- **814\_04** Enrollment Notification Response
- **814\_20** ESI ID Maintenance Request
